## INSTRUCTIONS

Use this form to request a Public Works Appeal. A Public Works Appeal is an appeal of non-technical decisions made by the Public Works Bureaus (Water, Transportation, and Environmental Services) as a result of reviewing an application for a public works permit, a building permit, or a land use review. Public Works Appeals do not alter completed land use reviews. You are advised to discuss your case with staff before filing an appeal against a completed land use review.

Prior to appealing a Public Works Permit decision, the applicant must have fully exhausted all available administrative remedies, including but not limited to variances, alternative methods reviews, design exceptions, special circumstance reviews, and bureau-level administrative reviews.

Examples of requirements that can be appealed are: the requirement for or size of a dedication, the requirement for the construction of improvements, the requirement for the width or location of a sidewalk, or the requirement to relocate water and sewer mains.

Do not use this form to request design exceptions for technical requirements that are part of a public works permit. For public works design exceptions, contact Public Works Permitting at [PublicWorksPermitting@portlandoregon.gov](mailto:PublicWorksPermitting@portlandoregon.gov) or (503) 823-1987. Examples of requirements not subject to a Public Works Administrative Appeal are changes in materials, thickness of materials, number of driveways, driveway location or width, and cross sections.
